The following have been added to plan coverage.

### Preferred Specialty Medications Added to Plan Coverage

Adalimumab-aaty, Adalimumab aacf (biosimilar to Humira)
SteQeyma (Ustekinumab- stba) (biosimilar to Stelara)

### Preferred Diabetes Medications and Supplies Added to Plan Coverage

Mounjaro (tirzepatide)
Freestyle Libre 3 Reader

### Misc. Generic Medications Added to Plan Coverage

Esomeprazole Magnesium for Delayed Release Susp Packet (generic for Nexium susp)
Nitrolingual spray (nitroglycerine spray)
Prucalopride (generic for Motegrity)

Lodoco 0.5 mg	Generic colchicine
Ocaliva	Generic ursodiol
Voquenza	Generic omeprazole, generic pantoprazole
Phentermine	n/a – plan exclusion; no alternatives
