First Choice Health Administrators is excited to announce a new electronic payment process using Zelis Payments (formerly known as RedCard). This alliance will help you streamline operations by accelerating and adding efficiency to your claim payment processing.

## **Why is this important to me?**

With the sunsetting of RedCard ACH, we want to ensure there is no interruption in your electronic claim payment processing. For the time being, payments will continue to be delivered via RedCard ACH with the transition to Zelis occurring no sooner than 07/01/2022.

Please review the matrix on the next page to determine how this change will affect your organization after 07/01/2022.
